Introduction

Human rights constitute the cornerstone of any just and democratic society, shaping the framework within which freedom, equality, and human dignity are safeguarded. The protection and promotion of human rights are intrinsically linked to the preservation of social cohesion, as they ensure justice and equal treatment for all citizens. Their entrenchment has been the subject of extensive negotiations, resulting in a complex network of legal instruments binding states at the national and international levels.

This report provides a systematic codification of the national, European, and international legal framework governing human rights in the Republic of Cyprus. It maps the fundamental constitutional guarantees, the provisions stemming from EU law, as well as the international conventions ratified by the Republic of Cyprus. Furthermore, it outlines the independent bodies and institutions responsible for the oversight and enforcement of these rights at the national level.

The aim of this report is to offer a comprehensive overview of the existing mechanisms for the protection of human rights within the institutional framework of the Republic of Cyprus, highlighting the legal safeguards that ensure their protection.

The NUP Human Rights Observatory

- Promoting the respect and protection of human rights in the Republic of Cyprus.
